STAFF RECOMMENDATION

COMES NOW the Staff ("Staff") of the Missouri Public Service Commission ("Commission") and for its recommendation in the above-captioned matter states as follows:

- 1. Laclede Gas Company (Company) filed a Motion for Waiver to Make an Adjustment to the Company's Budget Billing (Motion for Waiver).
- 2 Staff has reviewed the tariff filing and the Motion for Waiver and recommends that the Motion be granted. See Staff Memorandum at Attachment A.
- 3. Staff notes that this is a request for a one-time waiver from Laclede's tariff that permits review and adjustment of the Company's Budget Billing tariff on a semi-annual basis, in January and July.
- 4. Staff emphasizes that it has not audited the books and records of Laclede, and that it will conduct a thorough review of Laclede's gas purchases during the Actual Cost Adjustment (ACA) audit. These adjustments are interim subject to refund pending open ACA cases.

WHEREFORE, Staff recommends that the requested Motion for Waiver to Make an Adjustment to the Company's Budget Billing be granted.

Laclede Gas Company (Laclede or Company) filed a MOTION FOR WAIVER TO MAKE AN ADJUSTMENT TO THE COMPANY'S BUDGET BILLINGS (Motion for Waiver) on February 23, 2001. This Motion for Waiver from the Budget Billing Clause of Laclede's tariff (P.S.C. MO. No. 5 Consolidated, Original Sheet No. R-39) is being requested because the Public Service Commission (Commission) approved a second unscheduled PGA filing by the Company effective February 23, 2001. The unscheduled PGA decrease was filed by the Company and approved by the Commission due to a decline in the market price of gas since Laclede's first unscheduled winter PGA filing. Laclede cites the following reasons for approval of this Motion for Waiver:

- 1. The second unscheduled PGA adjustment was approved because it was a decrease from the first unscheduled PGA effective January 29, 2001, and the Company and Commission wanted the ratepayers to benefit from the price decrease. It also expedited the flow-through to ratepayers of the financial benefits of the Company's Price Stabilization Program.
- 2. The tariff provisions applicable to Laclede's budget billing process only allow the Company to review and adjust its budget billings twice a year, once in January, effective in February and in July, effective in August.
- The Company wants its budget-billing customers to receive a similar benefit from the PGA decrease that its other ratepayers will experience.

The Commission's Gas Department - Tariffs/Rate Design Staff (Staff) has reviewed the Motion and concurs with the Motion for Waiver request. The Commission has issued an ORDER SETTING PREHEARING CONFERENCE AND REQUIRING FILING OF PROCEDURAL SCHEDULE in GR-2001-387, which will not be effected by the Motion, and Staff knows of no other issues before the Commission
