ORDER CANCELLING REGISTRATION

Issue Date: July 22, 2025

Effective Date: August 1, 2025

On July 8, 2025, the Staff of the Commission (Staff) filed *Motion to Cancel Registration* (Motion). The Motion states that Hypercore Networks Inc. notified the Commission that it no longer wished to retain its registration to provide Interconnected Voice over Internet Protocol service (IVoIP) services in Missouri. The Motion states that Hypercore Networks notified the Commission in an indication on its Statement of Revenue filed for calendar year 2023. The Commission granted Hypercore Networks its IVoIP registration in the State of Missouri in Case No. DA-2018-0235.

Commission Rule 20 CSR 4240-28.011(3) permits a company to cancel a certificate of service authority or registration by filing a letter signed by the company's official that identifies when and which certificate, registration, and any applicable tariff to cancel. Based on the request of Hypercore Networks, the Commission finds that the IVoIP registration granted to it shall be canceled.

THE COMMISSION ORDERS THAT:

1. The registration to provide Interconnected Voice over Internet Protocol services, granted to Hypercore Networks Inc. in Case Number DA-2018-0235, is cancelled.

- 2. This order shall become effective on August 1, 2025.
- 3. This case may be closed on August 2, 2025.
