## ORDER TO PROVIDE ADDITIONAL INFORMATION

On November 6, 2020, Vearline Nelson filed two complaints with the Commission against Spire Missouri Inc., d/b/a Spire. The Commission's Staff filed a motion to consolidate the cases on November 19, 2020, stating that conversations between Staff Counsel and Ms. Nelson resulted in an agreement that the cases should be consolidated for administrative efficiency. Commission Rule 20 CSR 4240-2.110(3) allows the Commission to consolidate cases that involve related questions of law or fact. The Commission will order Staff to file a pleading stating what related questions of law or fact support consolidating the above captioned cases.

### THE COMMISSION ORDERS THAT:

1. Staff shall file a pleading stating what related questions of law or fact support consolidating Ms. Nelson's complaint cases no later than December 2, 2020.
2. This order is effective when issued.
