On October 8, 2020, Evergy Metro, Inc. d/b/a Evergy Missouri Metro filed an application for approval of three proposed tariff wording revisions as part of its Customer Forward Program. Evergy Missouri Metro requested approval of the tariff wording prior to filing revised tariffs in order to allow the wording revisions to undergo a customer testing program. The Staff of the Missouri Public Service Commission (Staff) filed its recommendation that the Commission approve the proposed tariff wording, with some wording modifications suggested by Staff and the Office of the Public Counsel. On November 4, 2020, the Commission issued an order approving the proposed tariff wording revisions with the wording modifications, leaving this file number open for receipt of the revised tariffs. On November 23, 2020, Evergy Missouri Metro filed its tariff revision sheets which were assigned Tariff No. YE-2021-0122. The effective date of the tariff revisions is January 18, 2021.

The Commission will direct Staff to file a recommendation as to whether the tariff revision complies with the Commission's order.

THE COMMISSION ORDERS THAT:

1. No later than December 14, 2020, Staff shall file a recommendation as directed in the body of this order.

2. This order shall be effective when issued.
