On October 30, 2020, Spire Missouri, Inc. filed an application seeking approval of an on-bill financing program and an associated cost recovery mechanism for the recovery of the program investments. The Commission directed notice and set a deadline of November 12, 2020, for applications to intervene. On November 13, 2020, Consumers Council of Missouri filed an application to intervene.

More than ten days have passed since the application was filed and no one has responded.
