On November 25, 2020, Spire Missouri Inc. d/b/a Spire filed the above-referenced tariffs that would modify its Commercial and Industrial rebate program language. In doing so, Spire withdrew previously filed Tariff No. JG-2021-0090 and JG-2021-0091. Spire states that it has filed Tariffs No. YG-2021-0125 and YG-2021-0126 after consulting with Staff.

The new tariffs bear an effective date of December 25, 2020. However, Spire asks the Commission to approve these tariffs no later than December 2, 2020, with an effective date of December 12, 2020.

The Commission has previously ordered Staff to file a Recommendation or alternative pleading no later than November 30, 2020 on Tariff No. JG-2021-0090 and JG-2021-0091. The Commission will now order Staff to respond to Spire's request for approval of Tariff No. YG-2021-0125 and YG-2021-0126.

#### THE COMMISSION ORDERS THAT:

- 1. The Staff of the Commission shall file its Recommendation or alternative pleading no later than November 30, 2020.
  - 2. Any other party may also respond no later than November 30, 2020.
  - This order shall be effective when issued.
