**ORDER APPROVING TARIFF IN COMPLIANCE WITH COMMISSION  
ORDER ON INFRASTRUCTURE SYSTEM REPLACEMENT  
SURCHARGE PETITION**

Issue Date: December 2, 2020

Effective Date: December 14, 2020

On August 28, 2020, Missouri-American Water Company (MAWC) filed a petition requesting the Commission authorize MAWC to change its infrastructure system replacement surcharge (ISRS) to recover the cost of eligible infrastructure system replacement in St. Louis County, as permitted by sections 393.1003 and 393.1006, RSMo (2016).<sup>1</sup> On November 24, 2020, the Commission issued its *Order on Petition to Change Infrastructure System Replacement Surcharge*. The Commission authorized MAWC to file an ISRS rate for each customer class as described in Staff's recommendation and the Commission's order.

On November 24, 2020, MAWC filed a compliance tariff sheet, assigned Tariff No. YW-2021-0124, with an effective date of December 24, 2020. Also on November 24, 2020, MAWC filed a *Motion for Expedited Treatment*, requesting the

proposed tariff sheet go into effect on December 14, 2020, “or as soon thereafter as is reasonable.” On November 25, 2020, Staff recommended the Commission approve the compliance tariff. No objections to the tariff sheet or the request for expedited treatment were received from any party.<sup>2</sup>

Based on Staff’s recommendation, the Commission finds the tariff sheet complies with the Commission’s November 24, 2020 order and will approve it.

Section 393.1006.1(3) requires a Commission order on a petition to change a water utility ISRS and any associated rate schedules to become effective no later than 120 days after the petition is filed. Therefore, the Commission’s order in this matter must be effective no later than December 26, 2020. In addition, MAWC requested the tariff sheet be approved to take effect on December 14, 2020. To approve the tariff sheet to take effect on December 14, 2020, the Commission will issue this order with an effective date fewer than 30 days from the date of issuance.

**THE COMMISSION ORDERS THAT:**

1. The following tariff sheet, assigned Tariff No. YW-2021-0124 and filed by MAWC on November 24, 2020, is approved and shall be effective on December 14, 2020:
