On April 4, 2001, Laclede Gas Company (Laclede or Company) of St. Louis, Missouri filed a tariff sheet proposed to become effective April 18, 2001. The tariff sheet was filed to reflect scheduled changes in Laclede's Purchased Gas Adjustment (PGA) factors as the result of changes in the cost of natural gas for the upcoming summer season. The summer season includes the months of April through October. Additionally, the L. P. Service factor will decrease.

The net effect of these changes will decrease the firm PGA factor for the summer season to \$0.67739 per therm from a winter season firm PGA factor of \$0.75311 per therm. The PGA factor would decrease by 10% under this proposal. When compared to the current rates, the effect of the proposed decrease on a typical residential customer's natural gas bills for the summer season is a 6% decrease.

Case No. GR-2001-387, under which this change was filed, was established to track the Company's PGA factors to be reviewed in its 2000-2001 Actual Cost Adjustment (ACA) filing. Final Commission decisions in Laclede's ACA Case Nos. GR-99-316, and GR-2000-622 for the 1998-1999, and 1999-2000 ACA periods respectively, are still pending. Interim subject to refund status should be maintained pending final Commission decisions in Case Nos. GR-99-316, GR-2000-622, and GR-2001-387.

The Commission's Gas Department - Tariffs/Rate Design Staff (Staff) has reviewed this filing and has determined that it was calculated in conformance with Laclede's PGA Clause. Staff is of the opinion that good cause for approval of this tariff sheet on less than thirty days notice is demonstrated by Laclede's Commission-approved PGA clause allowing for ten (10) business days notice for PGA change filings. Therefore, Staff recommends that the following tariff sheet be approved, interim subject to refund:

#### REMARKS

For a typical residential customer using approximately 312 Therms during the Summer Season (April - October), natural gas rates will decrease by \$23.61 or approximately 6% when comparing the fuel bills for the prior winter season rates ending March 2001. (As of 04/00, on the Laclede System 312 Therms are equivalent to about 305 Ccf.)

#### Notes:

- (1) Total fuel bill does not include gross receipts or local sales taxes.
- (2) Monthly usage priced at the rates in effect during the appropriate time period.

As a result of GR-99-315 the factor of \$.28489 per therm was deleted from the Energy Charge and included in the PGA.
