ORDER EXTENDING DEADLINE

On September 18, 2020,¹ the Commission issue its Order Directing Notice, Setting Date for Intervention and Ordering Staff Recommendation. The order required the Commission’s Staff (Staff) to file its recommendation no later than November 2. On October 27, Staff filed a Motion for Extension requesting the recommendation deadline be extended to December 2. The Commission granted the extension. On December 2, Staff filed another Motion for Extension, stating that due to some technical difficulties it was currently unable to file its recommendation in its entirety into EFIS. Staff requested that it be granted a two-day extension to December 4 to file its recommendation. The Commission will grant the request.

THE COMMISSION ORDERS THAT:

1. Staff’s Motion for Extension is granted.
2. Staff shall file its recommendation no later than December 4, 2020.
3. This Order shall be effective when issued.


