On November 10, 2020, the Commission directed the parties to propose available dates for hearing to include the period from December 14, 2020, through January 2021. On November 30, 2020, Staff and Missouri-American Water Company proposed a hearing on January 6, 2021. Mr. Scott did not respond to the Commission's order. Because of other events likely to be scheduled on that day, the Commission is not able to schedule the hearing as proposed.

The Commission will direct the parties to propose at least three potential hearing dates in January and February 2021, excluding the week of January 25, 2021. The parties may consult the Commission's hearing calendar, published at the Commission's website at <https://psc.mo.gov> to identify conflicts. Any hearing will be scheduled to begin in the morning.

THE COMMISSION ORDERS THAT:

1. No later than December 15, 2020, the parties shall propose available dates for hearing, as provided above.

3. This order shall be effective when issued.
