On November 19, 2020, in response to the national COVID-19 emergency, Union Electric Company d/b/a Ameren Missouri (Ameren Missouri) filed the above-referenced application for variances. On November 23, 2020, the Commission ordered its Staff to file a Recommendation or Status Report no later than December 7, 2020.

On December 7, 2020, Staff filed a Status Report which stated Staff planned to file its Recommendation no later than December 21, 2020. The Commission will order Staff to do so, and will allow other parties an opportunity to respond.
