ORDER APPROVING TARIFF SHEETS

Issue Date: December 9, 2020

Effective Date: December 20, 2020

On November 20, 2020, Union Electric Company d/b/a Ameren Missouri filed tariff sheets to remove language associated with energy efficiency programs that were applicable for 2016 through 2018. The blank tariff sheets, Sheet Nos. 201 through 217, Tariff No. YE-2021-0121, remove said language and state that they are reserved for future use. The tariff sheets bear an effective date of December 20, 2020.

The Commission's Staff (Staff) filed a recommendation regarding the tariff sheets on December 2, 2020. Staff recommends the Commission approve the tariff sheets. The Commission has received no responses to either Ameren Missouri's tariff sheets or Staff's recommendation.

The Commission has reviewed the tariff sheets and Staff's recommendation. The Commission finds that the tariff sheets that remove language concerning energy efficiency programs that were applicable for 2016 through 2018, but reserves the tariff sheet numbers for future use should be approved.

The Commission will issue its order with an effective date of December 20, 2020, to coincide with the thirty-day effective date of the proposed tariff sheets.

1. The tariff sheets filed by Ameren Missouri on November 20, 2020, and assigned Tariff No. YE-2021-0121 are approved to become effective on December 20, 2020. The tariff sheets approved are:
