# ORDER GRANTING EXTENSION OF TIME TO FILE STAFF REPORT

On September 25, 2020, the Commission issued notice and set a time for an answer to the complaint. The Commission also directed its Staff to file a report of its recommendations and investigation of the complaint within 45 days of the notice, which was later extended to December 10, 2020. On December 8, 2020, Staff filed a motion requesting clarification regarding the potential dismissal of Grand Property Management KC and for a further extension of time until January 5, 2021, to file its report.

The Commission finds Staff's request for additional time to be reasonable and will grant that request. In order to give the Commission sufficient time to address the potential dismissal of Grand Property Management KC, the Commission will extend Staff's filing deadline for an additional 10 days until January 15, 2021.
