On November 19, 2020, Staff filed a status report recommending that the Commission suspend Ameren Missouri's electrification pilot program tariff sheets for 90 days. Staff also stated that it was in discussion with the parties regarding a procedural schedule, and hoped to have the schedule filed within the next week. The Commission will order the Staff to file another status report indicating when a procedural schedule will be filed.
