ORDER FURTHER STAYING PROCEEDINGS AND ORDERING STATUS REPORT

Summit Natural Gas of Missouri, Inc. (SNGMo) applied for approval of its Cost Allocation Manual (CAM), which regulates the purchase of goods or services from an affiliated entity. On August 26, 2019, SNGMo and Staff jointly filed a motion asking the Commission to stay these proceedings because the revision of the Commission's rules concerning affiliate transactions is being considered in File Number AW-2018-0394.¹ The Commission stayed the proceedings and requested periodic status reports.

The most recent status report, filed jointly by all parties on December 11, 2020, indicated that the rule revisions, both File Number AW-2018-0394 related to affiliate transactions as well as File Number AW-2018-0393 related to customer information rulemaking, have not progressed due to COVID-19. Staff and SNGMo also state that SNGMo is not currently conducting affiliate transactions that would impact the company's Purchased Gas Adjustment or its Actual Cost Adjustment. All parties request the Commission continue its stay with direction to file a further status report by March 12, 2021.

¹ The Office of the Public Counsel expressed qualifications, but did not object to a stay.

The Commission considers this joint request reasonable and will continue the stay placed on these proceedings and will order a further status report.

THE COMMISSION ORDERS THAT:

1. The stay of proceedings granted in this case will continue.
2. The parties shall file a status report no later than March 12, 2021.
3. This order shall be effective when issued.
