## ORDER CANCELING IVOIP REGISTRATION

Effective Date: December 15, 2020

On December 1, 2020, Premiere Conferencing Networks, Inc. notified the Commission that it wishes to cancel its authority to provide Voice over Internet Protocol (VoIP) service in Missouri. The Commission granted that registration in File No. DA-2018-0168, on January 12, 2018.

The Commission directed its Staff to respond, and on December 15, 2020, Staff filed a recommendation advising the Commission to cancel Premiere Conferencing Networks, Inc.'s registration.

The Commission has the authority to cancel a registration pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on the company's request, and Staff's recommendation, the Commission finds that the registration granted to Premiere Conferencing Networks, Inc. shall be canceled.

### THE COMMISSION ORDERS THAT:

1. The registration to provide VoIP services granted to Premiere Conferencing Networks, Inc. in File Number DA-2018-0168, is canceled.

2. This order shall become effective on January 14, 2021.
3. This file may be closed on January 15, 2021.
