# ORDER DIRECTING LIBERTY RESPONSE

Issue Date: August 14, 2025 Effective Date: August 14, 2025

Liberty submitted Form 10-D to the Securities and Exchange Commission in January and July concerning its payments for securitization bonds. Those 10-D forms reported no investment earnings on the securitization General, Capital, and Excess Funds subaccounts under section 1.ii, Collections Allocable and Aggregate Amounts Available for the Current Payment Date. The Commission's securitization *Report and Order*<sup>1</sup> requires that the funds in those subaccounts be invested by the indenture trustee in short-term high-quality investments with the interest to pay principle and interest on the securitized utility tariff bonds.

The Commission cannot ascertain that Liberty is following the investment provisions of the Commission's securitization *Report and Order*. The Commission will direct Liberty to respond to the Commission on the status of its compliance with these provisions.
