ORDER GRANTING REQUEST FOR EXTENSION OF TIME

On November 4, 2020, The Raytown Water Company (Raytown) submitted an application requesting authority to issue preferred stock. The Commission directed a response from the Staff of the Missouri Public Service Commission (Staff) no later than December 21, 2020. On December 21, 2020, Staff filed a request for an extension of time until January 5, 2021.

Staff's request for an extension was due to the discovery of new information occurring on December 17, 2020. Staff's request states that Raytown is working to provide the information as quickly as possible.

The Commission considers the request to be reasonable and will grant it.

THE COMMISSION ORDERS THAT:

1. Staff's request for an extension of time to file its recommendation is granted. Staff shall submit its recommendation regarding Raytown's application no later than January 5, 2021.
2. This order shall be effective when issued
