On September 5, 2006, the Commission issued an order denying the late-filed application to intervene of W. Bill Dias, Natural Person, and W. Bill Dias d/b/a 1.paystation.com. The order denying the application to intervene was given an effective date of September 15.

On September 6, Mr. Dias filed a motion asking the Commission to reconsider the order denying his application to intervene. The Commission will grant reconsideration. On reconsideration, the Commission will withdraw its September 5 order. The Commission finds that Mr. Dias has shown good cause for his late filing for intervention. Furthermore, the Commission finds that Mr. Dias has an interest that is different than that of the general public and that his interest may be adversely affected by a final order arising from this case. Therefore, in accordance with 4 CSR 240-2.075(4), the Commission will grant his application to intervene.

IT IS ORDERED THAT:

1. The Commission's Order Denying Motion for Leave to File Application to Intervene Out of Time of W. Bill Dias, Natural Person, and W. Bill Dias d/b/a 1.paystation.com, and Denying Intervention, issued on September 5, 2006, effective September 15, 2006, is withdrawn and shall not go into effect.
2. The application to intervene of W. Bill Dias, Natural Person, and W. Bill Dias d/b/a 1.paystation.com is granted.
3. This order shall become effective on September 19, 2006.
