STAFF RECOMMENDATION

Comes now the Staff ("Staff") of the Missouri Public Service Commission ("Commission") and for its recommendation in the above-captioned Case states:

1. On July 7, 2000, Laclede Gas Company ("Laclede") filed a verified application for certain temporary revisions to its Price Stabilization Program ("PSP") for the second year of that program. The filing was made to address concerns about the status of the program in light of upward movements in the market price of natural gas since March of this year.

2. After considerable discussions among the Staff, Laclede and the Office of the Public Counsel ("OPC"), the parties filed a Unanimous Stipulation and Agreement on September 1, 2000, which provided for relaxing for this year the PSP provisions that require Laclede to procure price protection for 70% of its flowing natural gas supplies.

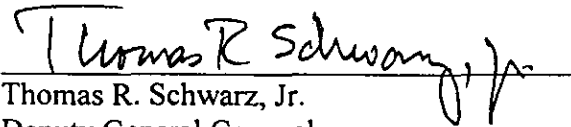
3. The Commission approved the Unanimous Stipulation and Agreement on September 28, 2000. Laclede made a compliance filing on October 5, 2000 ("October 5 filing").

4. The Staff has reviewed the October 5 filing, and is of the opinion that the filing implements the agreement of the parties, and complies with the Commission order. Therefore, Staff recommends that the Commission approve the October 5 tariff filing.

WHEREFORE, in light of the foregoing, the Staff recommends to the Commission that it forthwith approve Laclede's October 5, 2000, tariff filing in accord with the Unanimous Stipulation and Agreement, and with this the Commission's Order.

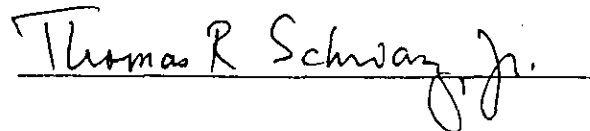
