This email chain shows an example of requirements that were added after the system was inspected. No where was it identified in the interconnect approval that the systems would need to be labeled according to the apartment numbers, rather than #1 and #2 as we had on our plans.

Amar,

There are two systems on this building, so they are labelled System #1 and System #2, which is how KCP&L Engineering requested they be labelled. The site plaques on the meters show location of equipment for each system, as well having "Caution: Power to this building is also supplied from the following sources:" language on them.

The disconnect may be rated for 225 amps, but it is fused for 80 amps. It was inspected and passed by the city on May 16th (permit # CPEM 201325356).

Please let me know what, if anything, needs to be updated in order to get the net meters installed.

I am not sure if this information was passed to the installer, but the labels still say "disconnect #1 and disconnect #2" instead of PS and 2W. Also, we need "caution label" (with appropriate wording) next to the meters as well.

Also the other issue noticed was that on Apt 2W, the disconnect has been changed to 225amps!!!

I am not sure if the existing meter bank is rated for 225amp breaker, if city inspection has been received on this, or if the paperwork submitted shows a 225amp service.

Attached is a pre approved project. An alteration order will be entered for pre inspection of metering to determine if the customer or vendor should take additional steps to bring it up to specifications prior to the completion of the net metering process.

In some cases the system may appear to be completed. The solar installer has the right to install but not interconnect the system prior to pre-approval. If the system appears to be complete:

- 1. Ensure that the disconnect is off. The solar array should not be energized prior to a final inspection as requested by the installer/owner.
- 2. Do not enter an exchange order until prompted by a field inspection request
