On August 4, 2025, the parties filed a *Full and Unanimous Stipulation and Agreement* (Stipulation) resolving all contested issues in the case. In their filing, the parties indicated they would be available for an on the record presentation, and stated that the signatories to the Stipulation will offer pre-filed testimony for acceptance onto the evidentiary record.

The Commission will now schedule an on-the-record presentation for the parties to answer Commission questions concerning their Stipulation.

THE COMMISSION ORDERS THAT:

1. An on-the-record presentation for the parties to present the Stipulation and respond to Commission questions is scheduled for August 27, 2025 at 9:30 a.m. It will be held in room 310 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri. This building meets accessibility standards required by the Americans with Disabilities Act. 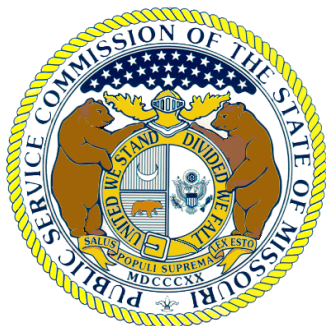
