## ORDER CLOSING CASE

On August 10, 2023, the Commission opened a file for investigation of a natural gas pipeline incident that occurred on July 17, 2023, in Springfield, Missouri in an area served by the municipal gas system of City Utilities of Springfield (CU).

On December 11, 2024, the Staff of the Commission (Staff) filed a *Gas Incident Report* in this matter.

On April 7, 2025, in Case No. GC-2025-0273, Staff filed a complaint against CU asserting violations of Commission pipeline safety rules and setting out recommendations to minimize the possibility of future violations.

On July 29, 2025, in Case No. GC-2025-0273, Staff and CU filed a non-unanimous Stipulation and Agreement resolving the complaint that was approved by the Commission on August 13, 2025.

On August 14, 2025, Staff filed a Status Report stating that, as a result of the Commission's August 13<sup>th</sup> Order in Case No. GC-2025-0273, no further action is required in this case. Thus, Staff requests this case be closed. No responses to the Status Report were filed.<sup>1</sup>

The Commission will grant Staff's request and close this case.
