Pursuant to 20 CSR 4240-28.011(2), Consolidated Communications of Missouri Company, LLC d/b/a Consolidated Communications (the "Company"), respectfully request that the Missouri Public Service Commission ("Commission") acknowledge their adoption of Fidium fictitious name. This change will have no impact on the rates, terms and conditions of the services customers receive from the Company.

The Company is authorized by the Commission to operate as an incumbent local exchange carrier¹.
