**FINDING OF NECESSITY AND ORDER DIRECTING PROPOSED
AMENDMENT 20 CSR 4240-10.165 BE FILED FOR PUBLICATION**

The Commission has undertaken this rulemaking to amend 20 CSR 4240-10.165 to address statutory changes to the "Fair Competition Law" as set out in sections 386.752, 386.754, and 386.756, RSMo, set forth in SS#2 SB4, First Regular Session of the 103rd General Assembly, effective August 28, 2025.

The Commission finds that amending the rule is necessary to protect the public interest and to carry out the purposes of the statute that granted the rulemaking authority. The Commission will seek further comments from interested stakeholders during the rulemaking process.

THE COMMISSION ORDERS THAT:

1. The Secretary of the Commission shall file the proposed amendment to Commission Rule 20 CSR 4240-10.165 with the Secretary of State for publication in the Missouri Register as a proposed rulemaking.
2. This order shall be effective when issued.

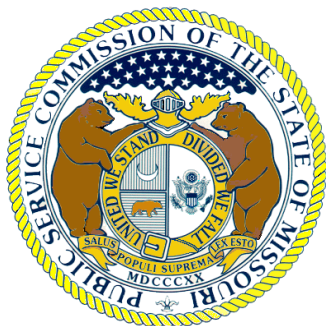
