**FINDING OF NECESSITY AND ORDER DIRECTING PROPOSED
AMENDMENT 20 CSR 4240-13.055 BE FILED FOR PUBLICATION**

The Commission has undertaken this rulemaking to amend the rule to address changes to section 393.109, RSMo, set forth in Senate Bill 4, effective August 28, 2025, relating to the "Cold Weather Rule." The proposed amendments also make some grammatical and editorial changes and correct some out-of-date references.

The Commission finds that amending the rule is necessary to protect the public interest and to carry out the purposes of the statute that granted the rulemaking authority. The Commission will seek further comments from interested stakeholders during the rulemaking process.

THE COMMISSION ORDERS THAT:

1. The Secretary of the Commission shall file the proposed amendment to Commission Rule 20 CSR 4240-13.055 with the Secretary of State for publication in the Missouri Register as a proposed rulemaking.
2. This order shall be effective when issued.
