

Response to Ameren's Motion To Continue

Ameren does no more than picks and chooses what they want to tell the Commission and want the Commission to believe. I can guarantee through all the emails that Ameren Missouri has received they are party that chooses to alter, manipulate and change the truth in the emails that they've received from Mr. Felber or anyone.
