On December 3, 2020, Union Electric Company d/b/a Ameren Missouri filed a tariff to adjust the rates of its Energy Efficiency Investment Charge. Ameren Missouri's tariff sheet bears a February 1, 2021 effective date. On December 29, 2020, Ameren filed a substitute tariff sheet to address the concerns of the Staff of the Commission. Staff performed an examination of the information provided by Ameren Missouri and filed a recommendation on December 31, 2020.

Staff determined the proposed adjustments are in accordance with Section 393.1075, RSMo, and applicable regulations. The Commission will set a time for responses to Staff's recommendation or the tariff.

THE COMMISSION ORDERS THAT:

1. Any responses to the tariff as substituted or to the Staff recommendation shall be filed no later than January 11, 2021.
2. This order shall be effective when issued.
