ORDER DIRECTING RESPONSES REGARDING LOCAL PUBLIC HEARING

On December 21, 2020, Carl Richard Mills filed a letter initiating a staff assisted rate case. Commission Rule 20 CSR 4240-10.075(6) requires a local public hearing to be scheduled in this case no later than February 19, 2021, unless the requirement is extended or waived.

The Staff of the Public Service Commission filed a rate case timeline for this case, as required by 20 CSR 4240-10.075(5). The timeline anticipates providing notice of a local public hearing to customers by mail on or about January 11, 2021. Written notice of a local public hearing must be mailed to customers at least 10 days prior to hearing.¹

To enable the Commission to schedule a local public hearing in this matter, the Commission will direct the parties to file a response recommending dates and times for a local public hearing. Because of the COVID-19 pandemic, a local public hearing will be conducted by telephone and/or video conference. The parties may consult the Commission's hearings calendar, published at the Commission's website at <https://psc.mo.gov>, to identify conflicts.²

THE COMMISSION ORDERS THAT:

1. No later than January 11, 2021, the parties in this case shall file a response recommending the time and date of a local public hearing. The parties shall identify at least two acceptable dates and times occurring before February 19, 2021, to enable the Commission to schedule a local public hearing.
2. This order shall be effective when issued.
