ORDER DIRECTING FILING

On September 17, 2020,¹ Missouri-American Water Company (MAWC) filed an application requesting a Certificate of Convenience and Necessity (CCN) to install, own, acquire, construct, operate, control, manage, and maintain a sewer system in and around Trimble, Missouri (Application). On September 18, the Commission issued an order directing notice, setting a deadline for intervention, and directing the Commission’s Staff (Staff) to file a recommendation. Staff filed a Recommendation on December 3, recommending that MAWC’s application be approved subject to certain conditions.

In its Application, MAWC requested authorization to service two territories: the City of Trimble and another area called Centennial Acres, which is a residential development of single family lots located near Trimble, Missouri. Subsequently to the Application, the Commission Staff and MAWC worked together to develop a proposed service area that is modified from that requested in the Application. The proposed modified service area map is shown in Attachment A to Staff’s Recommendation, and the modified written description is shown in Attachment B of Staff’s Recommendation. Staff recommended

that this proposed service area be approved, and that this service area be depicted in MAWC's tariff.

The modified service area depicted in Attachment A and described in Attachment B encompasses additional territory for which the Application did not seek a CCN. The Commission will direct the parties to file a pleading stating whether and how persons with an interest in the additional territory and in Commission action granting a CCN for service in those areas have been given notice of these proceedings. The Commission will also direct the parties to state whether there is any reason that additional notice should not be given that a CCN is sought for the additional territory depicted and described in Attachments A and B of Staff's Recommendation.

THE COMMISSION ORDERS THAT:

1. No later than January 8, 2021, the parties shall file pleadings stating whether and how all persons with an interest in the Commission's granting MAWC a CCN for the additional territory depicted and described in Attachments A and B of Staff's Recommendation have been provided due notice of these proceedings.

2. No later than January 8, 2021, the parties shall file a pleading stating whether there is any reason the Commission should not issue additional notice stating that MAWC seeks a CCN to provide sewer service as described in the Application for the additional territory depicted and described in Attachments A and B of Staff's Recommendation.

3. This order shall be effective when issued.
