**ORDER GRANTING ADDITIONAL TIME TO RESPOND**

Issue Date: August 28, 2025

On August 26, 2025, Union Electric Company d/b/a Ameren Missouri (Ameren Missouri) filed a motion requesting additional time to respond to Complainant's July 27, 2025, *Motion for Summary Determination*.

Ameren Missouri states that additional time is necessary to conduct discovery prior to responding to Complainant's motion. Commission Rule 20 CSR 4240-117(1)(D) authorizes the Commission to extend the response time for good cause. The Commission finds good cause to extend the time for Ameren Missouri to respond to Complainant's motion.

The Commission will grant Ameren Missouri's request.

**THE COMMISSION ORDERS THAT:**

1. Ameren Missouri is granted until September 30, 2025, to respond to Complainant's July 27, 2025, *Motion for Summary Determination*.

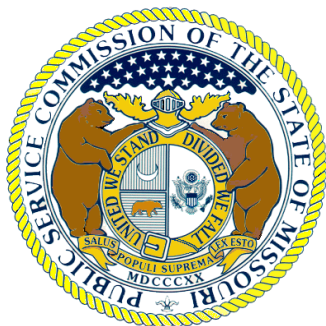
