Northeast Missouri Rural Telephone Company submitted a letter on December 29, 2020, advising that it has changed its name to Northeast Missouri Rural Telephone Company d/b/a NEMR Telecom. On January 6, 2021, the Commission's Staff filed a recommendation indicating the company has complied with all statutory and regulatory requirements for changing its name. Staff recommends the Commission recognize the name change. The Commission will do so.
