## ORDER SUSPENDING TARIFF SHEETS

On September 3, 2025, Missouri-American Water Company (MAWC) filed a petition and proposed tariff sheets to implement changes to its water and sewer infrastructure rate adjustments (WSIRAs). The tariff sheets bear an effective date of October 3, 2025 and were assigned Tracking Numbers JW-2026-0029 and JS-2026-0030.

The Commission will suspend the tariff sheets to allow the Staff of the Commission adequate time to perform its review of the petition and so that the Commission has adequate time to consider the petition.

### THE COMMISSION ORDERS THAT:

1. The tariffs sheets filed by MAWC on September 3, 2025, and assigned Tracking Nos. JW-2026-0029 and JS-2026-0030 are suspended until March 2, 2026.
2. This order is effective when issued.
