**AMEREN TRANSMISSION COMPANY OF ILLINOIS' MOTION TO REVISE  
CERTAIN PROCEDURAL SCHEDULE DATES AND FOR EXPEDITED TREATMENT**

COMES NOW Ameren Transmission Company of Illinois (ATXI or the Company), through its undersigned counsel, and for its Motion to Revise Certain Procedural Schedule Dates and for Expedited Treatment, states as follows:

1. Per the *Order Setting Procedural Schedule* issued in this proceeding by the Missouri Public Service Commission (Commission) on July 8, 2025 (July 8 Order), a procedural schedule was adopted which included the following:

Last Day for Discovery Requests	September 4, 2025
List of Issues and Witnesses, Order of Openings, Witness Testimony, and Cross Examination	September 9, 2025
Position Statements	September 16, 2025
Evidentiary Hearing	September 26, 2025
Post Hearing Briefs	October 16, 2025

The procedural schedule was entered based on the schedule contained in the *Joint Proposed Procedural Schedule* filed by Staff on June 23, 2025.

2. On August 21, 2025, the Commission issued its *Order Rescheduling the Evidentiary Hearing* (August 21 Order), rescheduling the Evidentiary Hearing from September 26, 2025, to October 27, 2025, to meet the scheduling needs of the Commission after taking into account the dates parties were available for a rescheduled Evidentiary Hearing. However, the August 21 Order did not revise any of the other procedural schedule dates set forth above. Those

dates were jointly proposed by the parties based on the September 26, 2025, Evidentiary Hearing date.

3. On September 3, 2025, counsel for ATXI emailed all parties to this proceeding, including Staff of the Commission and the Office of the Public Counsel, advising that ATXI intended to file a motion asking that the dates for the List of Issues, Position statements, and Post Hearing Briefs be moved to be commensurate with the timelines in the original procedural schedule as follows:

List of Issues and Witnesses, Order of Openings, Witness Testimony, and Cross Examination	October 10, 2025
Position Statements	October 17, 2025
Evidentiary Hearing	October 27, 2025
Post Hearing Briefs	November 18, 2025

4. ATXI Counsel's email to all parties also asked if the parties could advise him whether they supported ATXI's proposed modifications to the procedural schedule so that ATXI could include that information in its motion. All parties to this proceeding, including Staff and OPC, advised counsel for ATXI that they supported or did not oppose the requested procedural schedule revisions circulated by counsel for ATXI, although some of the parties conditioned their support on also extending the Last Day for Discovery Requests to September 12, 2025. Counsel for ATXI advised all parties that the motion would also include a revision of the discovery cut-off date to September 12, 2025.

5. The revised procedural schedule dates set forth above will afford all parties additional time which will be helpful in preparing the documents and brief required by the procedural schedule and is reasonable given the revised Evidentiary Hearing date. Because the first procedural schedule date to be revised currently has a due date of September 9, 2025, and all parties have advised that they support or do not oppose this Motion, ATXI respectfully requests

that the Commission enter its order revising the procedural schedule as set forth in this Motion by September 9, 2025.

WHEREFORE, ATXI respectfully requests the Commission enter an order revising the procedural schedule as follows:

List of Issues and Witnesses, Order of Openings, Witness Testimony, and Cross Examination	October 10, 2025
Position Statements	October 17, 2025
Evidentiary Hearing	October 27, 2025
Post Hearing Briefs	November 18, 2025
