STAFF RECOMMENDATION

COMES NOW Staff of the Missouri Public Service Commission (“Staff”), and for its *Staff Recommendation* regarding Union Electric Company d/b/a Ameren Missouri’s (“Ameren Missouri”) tariff sheet, assigned Tracking No. JE-2026-0027, respectfully states as follows:

1. On August 29, 2025, Ameren Missouri submitted a revised tariff sheet, assigned Tracking No. JE-2026-0027 with an effective date of October 1, 2025, to true-up its Securitized Utility Tariff Charge and incorporate revised SUR calculations.
2. The submitted revised tariff sheet, PSC Mo. No. 6, 6th Revised Sheet No. 90.4, will supersede PSC Mo. No. 6, 5th Revised Sheet No. 90.4.
3. On September 2, 2025, the Commission issued an *Order Directing a Staff Tariff Recommendation and Setting Time for Responses* concerning Ameren Missouri’s proposed tariff revision, ordering Staff to file its recommendation on the tariff sheet no later than September 10, 2025.
4. Staff has reviewed the Company’s filing pursuant to the applicable statute, § 393.1700.2(3)(e), RSMo., and recommends the Commission approve the following tariff sheet, originally filed on August 29, 2025, to go into effect on and after October 1, 2025, the requested effective date:

6th Revised Sheet No. 90.4 Cancelling 5th Revised Sheet No. 90.4

and prays the Commission issue an order accordingly.
