- 1. On August 29, 2025, Ameren Missouri submitted a revised tariff sheet, assigned Tracking No. JE-2026-0027 with an effective date of October 1, 2025, to true-up its Securitized Utility Tariff Charge and incorporate revised SUR calculations.
- 2. The submitted revised tariff sheet, PSC Mo. No. 6, 6th Revised Sheet No. 90.4, will supersede PSC Mo. No. 6, 5th Revised Sheet No. 90.4.
- 3. On September 2, 2025, the Commission issued an *Order Directing a Staff Tariff Recommendation and Setting Time for Responses* concerning Ameren Missouri's proposed tariff revision, ordering Staff to file its recommendation on the tariff sheet no later than September 10, 2025.
