ORDER GRANTING MOTION FOR AN EXTENSION OF TIME TO FILE A REPORT

On July 2, 2025, Mr. Jonathan Miller (“Complainant”) filed a complaint with the with the Missouri Public Service Commission (“Commission”) against Spire Missouri, Inc. d/b/a Spire (“Spire”), pursuant to Commission Rule 20 CSR 4240-2.070.2. On July 18, 2025, the Commission issued an order regarding Complaint Case procedures prescribed in Commission Rule 20 CSR 4240-2.070(15). In the same order, the Commission also directed Staff to file an investigation report or a status report by August 31, 2025.

Commission Rule 20 CSR 4240-2.070(15)(D) requires Staff to file a report within 45 days of the Complaint filing. On August 28, 2025 Staff of the Commission filed a *Staff Report and Motion for Extension of Time to File Its Report*, requesting until October 21, 2025 to file its report and citing filed Data Requests whose deadline exceeds the forty five day report requirement.

The Commission will grant the Continuance Staff requested and deny all other pending Motions.

1. The Commission will grant the Extension of Time requested by Staff and deny all other pending Motions.
2. This order shall be effective September 10, 2025.
