ORDER APPROVING TRUE-UP ADJUSTMENT TARIFF

Issue Date: September 18, 2025

Effective Date: October 1, 2025

On August 29, 2025, Union Electric Company d/b/a Ameren Missouri, submitted a revised tariff sheet for the Company's first annual true-up of its Securitized Utility Tariff Charge Rider (SUTC). That tariff sheet bears an October 1, 2025 effective date.

The Commission directed its Staff (Staff) to file a recommendation about Ameren Missouri's true-up adjustment tariff sheet and set time for other responses.

Staff filed a recommendation on September 10, 2025, stating that Staff had reviewed Ameren Missouri's tariff revision pursuant to Section 393.1700.2(3)(e), RSMo. Section 393.1700.2(3)(e), RSMo. requires Ameren Missouri to, at least annually, file a petition or letter applying a formula-based true-up mechanism adjusting the SUTC for the Commission's approval. Staff recommends that the Commission approve Ameren Missouri's true-up adjustment tariff sheet to take effect on October 1, 2025.

No other responses to Ameren Missouri's tariff revision were received.

The Commission reviewed the tariff sheet and Staff's recommendation and finds that the tariff sheet should be approved. The Commission will approve Ameren Missouri's

tariff sheet to become effective on October 1, 2025. Accordingly, the Commission finds it reasonable to make this order effective in less than 30 days so that the order will be effective concurrently with the tariff sheet.

THE COMMISSION ORDERS THAT:

1. The following tariff sheet filed by Ameren Missouri on August 29, 2025, assigned Tracking No. JE-2026-0027, is approved to become effective on October 1, 2025:
