Dear Hon. Dippell:

Pursuant to the December 8, 2022 *Order Approving Settlement* issued in Docket No. EA-2022-0234 ("Order"), NextEra Energy Transmission Southwest, LLC ("NEET Southwest") hereby submits its post-construction filing on completion of the NEET Southwest Wolf Creek-Blackberry 345 kV Transmission Project that spans Barton and Jasper counties in Missouri, as well as five counties in Kansas ("Project").

GENERAL OVERVIEW

In the second quarter of 2025, NEET Southwest completed construction activities on the Project, and the Project was energized on July 15, 2025. Pursuant to the Order, after completion of construction activities, NEET Southwest is required to file certain information, documents, or reports, including:

- Item 1: Final Operations and Maintenance Plans for the project,
- Item 2: Final 345 kV Transmission Line Restoration Plan,
- Item 3: Final Storm Outage and Emergency Response Plan
- Item 4: Final Communications Plan
- Item 5: Contracts for vendor support services including but not limited to any contract with vendor(s) providing response to unplanned outages
- Item 6: Contract for vendor providing unplanned outage response times and equipment availability specifications for the Missouri Project

NEET Southwest has included with this filing copies of documents responsive one or more of these categories that are available at this time:

- CONFIDENTIAL NEET Southwest Operations and Maintenance Plan (Item 1)
- CONFIDENTIAL NEET Southwest Line Restoration Plan (Item 2 and 3)

- CONFIDENTIAL NEET Southwest-Northstar Energy Solutions Vendor Contract (Items 5 and 6)


