## ORDER GRANTING MOTION FOR LEAVE TO LATE FILE REBUTTAL TESTIMONY

On July 8, 2025,¹ the Commission ordered a procedural schedule requiring that Rebuttal Testimony be filed by August 14. Ameren Transmission Company of Illinois (ATXI) filed the Rebuttal Testimony of Sam Morris, James Nicholas and Leah Dettmers shortly after midnight on August 15. On August 20, the Commission held a procedural conference, during which the late filed testimony was discussed and the Presiding Officer directed ATXI to file a motion for leave for the late filed testimony. On September 3, 2025, ATXI filed a *Motion for Leave to Late File Rebuttal Testimony of Sam Morris, James Nicholas and Leah Dettmers* (Motion). Within the Motion, ATXI states that the unplanned unavailability of ATXI's counsel and that there was uncertainty regarding the confidentiality of the Direct Testimony of the landowner intervenors, causing the slight delay in filing. The Motion also states that no party was or will be prejudiced by the late filing of the rebuttal testimony. Ten days have passed and no responses have been received.
