NOTICE RECOGNIZING NAME CHANGE

Issue Date: September 19, 2025

On August 26, 2025, the Commission received a request from Consolidated Communications of Missouri Company, LLC d/b/a Consolidated Communications to recognize its name change to Consolidated Communications of Missouri Company, LLC d/b/a Consolidated Communications d/b/a Fidium. The company also requested the Commission approve the submitted adoption notices and revised tariff title sheets, assigned Tracking Nos. JI-2026-0018, JI-2026-0019, JI-2026-0020, JI-2026-0021, JI-2026-0022, JI-2026-0023, and JI-2026-0024. The submitted adoption notices and revised tariff title sheets all have an effective date of September 26, 2025.

On September 18, 2025, Consolidated Communications filed substitute tariff sheets for Tracking Nos. JI-2026-0018, JI-2026-0019, JI-2026-0022, and JI-2026-0023. Those tariff sheets indicate the name change is only changing the d/b/a designation to Fidium. Additionally, Consolidated Communications stated it was withdrawing the proposed changes to Tracking Nos. JI-2026-0020, JI-2026-0021, and JI-2026-0024 as it has no customers under those tariffs.

The Commission has reviewed the filings and 20 CSR 4240-28.011(2), and finds the company has complied with all statutory and regulatory requirements for changing its name. The Commission recognizes the name change of Consolidated Communications of Missouri Company, LLC d/b/a Consolidated Communications to Consolidated Communications of Missouri Company, LLC d/b/a Fidium.

The Commission gives notice that it recognizes the name change and that the adoption notices and revised tariff title sheets will go into effect by operation of law.
