ORDER DIRECTING SCHEDULES TO BE FILED AND GRANTING MOTION TO SUBMIT CORRECTED FILING

On November 24, 2020, Staff filed its *Staff Report – Cost of Service* and its accounting schedules in support of that report. So that the Commission has the ability to review and understand the magnitude of adjustments by issue and the accounts that are affected, the Commission will direct Staff to file additional accounting schedules that have been omitted. The Commission directs Staff to file accounting schedules for this case similar to the plant, depreciation reserve, and income statement adjustment detail schedules that were filed in prior Missouri American Water Company (MAWC) rate case File No. WR-2008-0311 and that are typically included in all major electric and natural gas rate cases.¹ The inclusion of these additional Staff accounting schedules will enhance and streamline the Commission's review of evidence in the rate case.

Additionally, on December 9, 2020, Staff filed its *Staff Report on Class Cost of Service and Rate Design*, which included Schedule 2. On December 17, 2020, Staff
