**ORDER SETTING PREHEARING CONFERENCE**

On June 17, 2025, Roger Dale Barber filed a Complaint against Liberty Utilities (Missouri Water), LLC, d/b/a Liberty (hereafter "Liberty") disputing the date his water meter was exchanged and the meter readings after the exchange, resulting in him questioning the amount of the bill. On June 23, 2025, the Commission issued a Notice of Complaint and Order Directing Answer ("Order"). In its Order, the Commission directed Liberty to file an answer, and Staff to file its investigation report or a status report with the Commission no later than August 22, 2025. Liberty filed its Answer to Complaint on July 23, 2025 and Staff filed a recommendation and report on August 22, 2025.

A prehearing conference is now appropriate so the parties may discuss whether a hearing is needed and, if so, what dates would be appropriate for that hearing.

**THE COMMISSION ORDERS THAT:**

1. The Commission will convene a prehearing conference on October 15, 2025, at 10:00 a.m., via WebEx. The Commission will send parties information needed to access WebEx for the conference via email.
2. This order shall be effective when issued.
