## ORDER APPROVING TARIFF SHEET IN COMPLIANCE WITH COMMISSION ORDER

Issue Date: July 15, 2022 Effective Date: July 31, 2022

On April 6, 2022, the Commission issued its Report and Order in The Empire District Electric Company d/b/a Liberty's general rate proceeding. The Report and Order authorized Liberty to file compliance tariff sheets to implement the Report and Order's terms. On May 17, June 16, and July 8. 2022, the Commission approved compliance tariff sheets filed by Liberty.

On July 1, 2022, Liberty filed additional Tariff Revision YE-2023-0001, with an effective date of July 31, 2022. Liberty explains that it discovered that a revised tariff sheet was not filed to address updates associated with the settlement terms for Liberty's Low Income Pilot Program.

The Commission ordered its Staff to file a recommendation about the compliance tariff sheet by July 14, 2022. Other parties were also given until that date to file any comments concerning the compliance tariff sheet. Staff timely recommended the Commission approve the compliance tariff sheet. No other comments were received.

After reviewing the compliance tariff sheet and Staff's recommendation, the Commission finds the tariff sheet complies with the Commission's Report and Order. So

that Liberty can implement the compliance tariff sheet on its effective date, the Commission finds it reasonable to make this order effective in less than thirty days.

#### THE COMMISSION ORDERS THAT:

1. Liberty's following compliance tariff sheet, Tracking No. YE-2023-0001, is approved to become effective on and after July 31, 2022:
