NOTICE OF COMPLIANCE WITH ORDER AND STIPULATION

Issue Date: September 24, 2025

On July 29, 2025,¹ City Utilities of Springfield, Missouri (City Utilities) and Staff filed a *Full and Unanimous Stipulation and Agreement* (Agreement). Although purported to be unanimous, the Office of the Public Counsel (Public Counsel) was not a signatory to the Agreement. However, according to the Agreement, Public Counsel was advised of the Agreement and did not object to it.

Paragraph 9(l) of the Agreement states:

“In the interest of resolution of this case, City Utilities agrees to pay the sum of \$60,000 to the Public-School Fund of Missouri. The payment shall be due within thirty (30) calendar days of the effective date of a Commission order of this Agreement.”

On August 13, the Commission issued an order approving the Agreement, with an effective date of August 23. A check was received by the Commission on September 22

from City Utilities in the amount of \$60,000, which was then deposited into the Public-School Fund of Missouri on September 23.

On September 23, the Commission erroneously issued a *Notice Regarding Clarification*, which has been replaced with this notice.

The Commission acknowledges receipt and payment of the disclosed amount to the Public-School Fund of Missouri in compliance with the August 13 Commission Order and Paragraph 9(l) of the Stipulation.

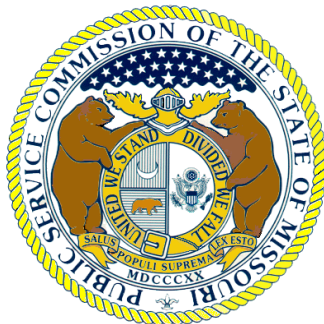
