**PROPOSED PROCEDURAL SCHEDULE**

COME NOW Greeley Gas Company ("Greeley" or "Company"), the Staff ("Staff") of the Missouri Public Service Commission ("Commission") and the Office of the Public Counsel ("OPC") and for their proposed procedural schedule, respectfully state as follows:

1. On March 2, 2001, the Commission issued its Order Setting Prehearing Conference and Requiring Filing of Procedural Schedule, wherein the parties were directed to file, no later than April 4, 2001, a proposed procedural schedule to address Greeley's Purchased Gas Adjustment Factors to be Audited in its 2000-2001 Actual Cost Adjustment ("ACA").

2. Pursuant to the Commission's directive, the undersigned parties propose that the following procedural schedule be established:

July 16, 2001	Greeley makes its 2000-2001 ACA books and work papers available to Staff for audit
July 31, 2001	Greeley answers Staff's standard DRs (forty-nine in number)
December 4, 2001	Staff Recommendation
January 4, 2002	Company Response

February 5, 2002	Direct Testimony (all parties wishing to file)
March 7, 2002	Rebuttal Testimony (all parties wishing to file)
March 14, 2002	Issues List to be filed
March 21, 2002	Position Statements (all parties)
April 1, 2002	Surrebuttal Testimony (all parties wishing to file)
April 8, 2002	Hearing

3. The Staff would note its expectation, as a result of the need to prioritize in allocating scarce resources, that the filing of any testimony as well as any hearing in the 1999/2000 Greeley ACA case (Case No. GR-2001-36) will be delayed to coincide with the schedule proposed above, and that ultimately the two cases would be consolidated for those purposes.

WHEREFORE, the undersigned parties respectfully request that the Commission issue an order adopting the proposed procedural schedule set forth herein.
