STAFF RECOMMENDATION

COMES NOW the Staff of the Missouri Public Service Commission ("Staff") and respectfully states:

- 1. On June 15, 2001, Greeley Gas Company ("Greeley" or "Company") filed with the Missouri Public Service Commission ("Commission") a tariff sheet reflecting unscheduled changes in Greeley's Purchased Gas Adjustment ("PGA") factors as a result of changes in the cost of natural gas for the remainder of the summer season. In conjunction with the tariff sheet, which is proposed to become effective on July 1, 2001, Greeley also filed on June 15 a request for a one-time variance from the PGA clause of the Company's tariff.
- 2. In the attached Memorandum, which is labeled Appendix A, the Staff recommends that the Commission grant Greeley's request for a variance and approve the Company's proposed tariff sheet on an interim-subject-to-refund basis.

WHEREFORE, the Staff respectfully requests that the Commission issue an order in accordance with the recommendations in the Staff's Memorandum attached hereto.

SUBJECT: Staff Recommendation for Greeley Gas Company's Request for a One-

time Variance and an Unscheduled Summer Season PGA Filing

Effective July 1, 2001.

DATE: June 21, 2001

On June 15, 2001, Greeley Gas Company (Greeley or Company), a Division of Atmos Energy Corporation of Dallas, Texas, filed a tariff sheet proposed to become effective July 1, 2001. The tariff sheet was filed to reflect unscheduled summer changes in Greeley's Purchased Gas Adjustment (PGA) factors as the result of estimated changes in the cost of natural gas. The summer season includes the months of April through October.

In conjunction with the filing of this tariff sheet, Greeley filed a REQUEST FOR VARIANCE FROM TARIFF PROVISIONS (Motion). This Motion requests a one-time variance from the PGA Clause of Greeley's tariff due to a lowering of the market price of gas since its last change in PGA rates on February 1, 2001. In addition, Greeley cites the following reasons for approval of this one-time variance:

- Give a more accurate price signal to consumers regarding the current cost of natural gas; and
- Help keep the Deferred Carrying Cost Balance (DCCB) and the Actual Cost Adjustment (ACA) balances at appropriate levels and not create significant over-collections or under-collections that would need to be reflected in future periods.

The net effect of these changes will decrease the firm PGA factor for the remainder of the 2001 summer season to \$0.5736 per Ccf from the unscheduled 2000-2001 winter season firm PGA factor of \$0.7339 per Ccf. The firm PGA factor would decrease 21.8% under this proposal.

Case No. GR-2001-394 under which this change was filed, was established to track the Company's PGA factors to be reviewed in its 2000-2001 ACA filing. Case No. GR-2001-36 was established to track the Company's PGA factors to be reviewed in its 1999-2000 ACA filing. refund status should be maintained pending final Commission decisions in Case Nos. GR-2001-394 and GR-2001-36.

The Commission's Energy Department - Tariffs/Rate Design Staff (Staff) has reviewed the Motion and agrees that a one-time variance request should be granted. Staff has also reviewed the PGA filing and has determined that, with the exception of the one-time variance request to file an unscheduled summer PGA, this filing was calculated in conformance with Greeley's PGA Clause. Staff is of the opinion that good cause for approval of this tariff sheet on less than thirty days notice is demonstrated by Greeley's Commission-approved PGA clause allowing for a minimum of ten (10) business days notice for PGA change filings. Therefore, Staff recommends that the Commission grant the one-time variance as requested by the Company on June 15, 2001 and approve the following tariff sheet to become effective July 1, 2001, interim subject to refund:
