**ORDER GRANTING MOTION FOR WAIVER
AND APPROVING INTERIM RATES**

Greeley Gas Company, (Greeley) submitted a tariff sheet to the Commission on June 15, 2001, carrying an effective date of July 1, 2001. The proposed tariff sheet was filed to reflect unscheduled changes in Greeley's Purchased Gas Adjustment (PGA) factors as the result of falling wholesale prices of natural gas. The net effect of the changes proposed by Greeley will decrease the firm PGA factor for the remainder of the 2001 summer season. The changes will decrease the firm PGA factor to \$0.5736 per Ccf from \$0.7339 per Ccf.

Along with its proposed tariff, Greeley filed a Request for Variance from Tariff Provisions to permit it to file an unscheduled Summer Purchased Gas Adjustment rather than delaying its next adjustment to the PGA factor until its next scheduled filing.

The Staff of the Commission filed a memorandum and recommendation on June 26, 2001, stating that the changes in Greeley's PGA were calculated in conformance with the Company's approved PGA Clause, and that Greeley's tariff permits the filing of proposed PGA tariffs on ten days' notice. Staff also recommends that the Commission grant Greeley's Request for Variance from Tariff Provisions. Staff recommends that the

Commission approve the tariff sheet to become effective July 1, 2001, on an interim basis, subject to refund.

The Commission has reviewed the proposed tariff sheet and Staff's recommendation and memorandum, and finds that the tariff sheet conforms to Greeley's Commission-approved PGA Clause and is therefore reasonable.

IT IS THEREFORE ORDERED:

1. That Greeley Gas Company's Request for Variance from Tariff Provisions is granted.

2. That the tariff sheet submitted on June 15, 2001, by Greeley Gas Company, is approved on an interim basis, subject to refund, to become effective on July 1, 2001.


