Dear Secretary Dippell,

Accompanying this letter for filing via the Missouri Public Service Commission's ("Commission") Electronic Filing and Information System are revised tariff sheets designed to increase Spire Missouri Inc.'s ("Spire Missouri") aggregate annual gross base rate revenues by \$210 million, consistent with the Commission's September 3, 2025 Order Approving Stipulation and Agreement.

The approved increase equates to approximately a 10.05% bill increase or \$8.21 a month for the average Spire Missouri East residential customer and approximately a 10.53% bill increase or \$8.93 a month for the average Spire Missouri West residential customer. The bill impact could be higher or lower depending on customer usage.

The accompanying tariff sheets issued by Spire Missouri are transmitted to you for filing as P.S.C. MO. No. 9, Schedule of Rates and Charges Applying to Spire Missouri Service Areas and Spire Missouri Rules and Regulations. The tariffs have an issuance date of September 24, 2025, and an effective date of October 24, 2025.

Please bring this filing to the attention of the appropriate Commission personnel.
