SECOND ORDER DIRECTING FILING

This order sets the time for the filing of responses to Staff's Motion for Extension of Time and for Expedited Treatment and directs Staff to file a revised procedural schedule.

The Commission previously directed Staff to file a memorandum and recommendation after reviewing the natural gas costs of Greeley Gas Company for the 2000-2001 Actual Cost Adjustment period. Staff was ordered to file its recommendation no later than December 4, 2001.

On November 21, 2001, the Staff of the Missouri Public Service Commission filed a motion requesting that the Commission extend the time for filing its recommendation until January 18, 2002. Staff also requested that the Commission grant its motion on an expedited basis.

Because of the quickly approaching procedural dates, the Commission will direct that any responses to the motion shall be filed as directed below. The Commission will also require Staff to file a proposed revised procedural schedule that incorporates the effects of the extension of time, if granted, on the remainder of the procedural schedule.



IT IS THEREFORE ORDERED:

- 1. That any responses to Staff's Motion for Extension of Time and for Expedited Treatment shall be filed no later than November 29, 2001.
- 2. That the Staff of the Missouri Public Service Commission shall file no later than November 29, 2001, a proposed revised procedural schedule that incorporates the requested extension of time.
 - 3. That this order shall become effective on November 29, 2001.
